Abstract: This collection of documents from the Edgartown Federated Church consists of materials dated from roughly 1925, which is when the Congregational Church merged with the Edgartown Baptist Society to become the Federated Church. Documents include business and financial papers, membership records, publications, ledgers, and guest books. Newspaper clippings reflecting activities and the history of the church are also included.

Historical Note

The history of the Edgartown Federated Church goes back to 1642, when Thomas Mayhew established the First Church of Christ on Martha's Vineyard. This church, also known as the Edgartown Congregational Church, became the Federated Church in 1925. That year the Edgartown Baptist Society and the Congregational Church merged. It has been speculated that due to dwindling membership and resources the two organizations joined forces. It appears the Congregational Church invited the Baptists to "unit with them in preaching services and prayer meetings. Later Federated Church records (1945) report, "our churches happily united in a federation by which we conserved our resources, advanced the cause of Christian unity and opened the way for our churches to do the work of the Kingdom in Edgartown more effectively." Although the congregations were united, two church buildings continued to be used. Members met for work and worship six months per year in each building. This continued until 1945 when the prospect of prohibitive renovations to the Baptist church united the congregation under one roof, that of the former Congregational church, now the Federated Church.

Today the church no longer keeps track of members' faith. In fact the church now includes members from other denominations. In 1991 Rev. John D. Schule remarked that this diversity keeps them strong, noting "We agree to disagree." The current church, built in 1828 by Frederick Baylies, Jr, is lovingly cared for. The history of the church is also celebrated with events marking the 100th, 300th, and 350th anniversaries of church presence in Edgartown.

Scope and Content Note

This collection of documents from the Edgartown Federated Church consists of business and financial papers, meeting minutes, member records, guest books,

news clippings, and publications. Many of the account books, church registers, and guest books are bound ledgers. Most of these documents date from 1925 or later, which is the year the Baptist Society and Congregational Church merged. Records relating to the Baptist Society may be found in Record Unit 342; records relating to the Congregational Church are located in Record Unit 341.

Information on the joining of the two congregations and the merger of the use of the two church buildings in 1945 may be found in Series I. Some Baptist Society Records, and Congregational Records remain separate in this collection and are located in Series II, and Series III, respectively. The Unity Club's records have remained intact, and begin prior to the 1925 merger.

Please note that there are restrictions of access and use to some of the Federated Church materials. Specifically, the donor has requested that a 24 year restriction be applied to post-1945 financial records. If a user is interested in accessing these materials, he/she will need to speak to the Museum's archivist. The archivist, in turn, will forward the user's petition to the appropriate members of the Federated Church.
