#### **Historical Note**

The Grand Army of the Republic became the preeminent veterans' organization formed at the close of the Civil War. It was based upon three objectives: fraternity, charity, and loyalty. The first ideal was encouraged through regular locally scheduled meetings as well as joint gatherings with members from other posts.

Its second objective, charity, was depicted in several ways: the veterans set up a fund for the relief of needy veterans, widows, and orphans which was used for medical, burial and housing expenses, and for purchases of food and household goods, as well as arranging loans. Sometimes the veterans found work for the needy. The G.A.R also had a number of auxiliaries: the Woman's Relief Corps (organized on a national basis in 1883); the Ladies of the Grand Army of the Republic (1896); and the Sons of Union Veterans of the Civil War (1881). These three organizations along with the Daughters of Union Veterans of the Civil War, and the Auxiliary to the Sons of Union Veterans of the Civil War still carry on the work begun by the G.A.R in establishing and improving veterans facilities.

Loyalty, the third ideal, was fostered through constant reminders to those who had not lived through the war of the significance of the G.A.R in reuniting a divided nation. The organization spent much of its time soliciting funds for monuments and memorials, busts and equestrian statues of Union soldiers and heroes, granite shafts, tablets, urns, and mounted cannon. The G.A.R also encouraged the preservation of Civil War sites, relics, and historic documents. Cannons and field-pieces were placed in many towns or courthouse squares and parks. The members also gave battle-stained flags, mementos, and documents to local museums.

The G.A.R.'s principal legacy to the nation is the annual observance of Memorial Day, which is now observed on the last Monday in May. General John A. Logan, Commander-in-Chief of the G.A.R., requested members of all posts to decorate the graves of their fallen comrades with flowers on May 30, 1868; in subsequent years, it was to include fallen veterans of all wars.

## Scope and Content

This collection consists primarily of record logs of the G.A.R. post in Cottage City (Oak Bluffs), Massachusetts from its inception on June 19, 1890 until 1918, as well as a section on two Woman's Relief Corps on Martha's Vineyard, one in Cottage City, the other in Edgartown.
